Lewisporte Stadium: Covid-19 User Agreement and Restrictions

The risk of spreading Covid 19 is highest within 2 meters of each other for 15 minutes while taking deep breaths (example exercising); because of this, sports occurring indoors and/or in close proximity to others, are considered higher risk.

With this in mind, and following the Government of Newfoundland and Labrador Guidelines, the Town of Lewisporte have developed regulations that all user groups will have to follow in order to be permitted use of the Lewisporte Stadium.

- All user groups are required to submit contact tracing information at the end of each ice rental for participants, coaches, officials, supervisors, care or respite workers, and spectators. This information will be kept for a minimum of 14 days, and if needed only provided to the Department of Health and Community Services to assist with contact tracing efforts.
- Anyone considering entering the stadium is expected to stay home if unwell or symptomatic.
- All users will be required to sanitize their hands at the provided stations upon entering the stadium.
- All user groups, participants, players, coaches, and spectators are expected to wear a mask while inside the stadium. Participants can remove mask when getting on the ice. While in the bench area coaches, managers, and other personnel verbally interacting with participants are expected to maintain wearing a mask.
- The stadium will have one designated entrance and one designated exit. During the ice rental the entrance will be locked allowing exit only and there will be no re-entry. This measure is in place to ensure the set maximum number of people allowed is not exceeded.
- There may be 50 participants on the ice surface area per session (unless user group regulations dictate other wise, whichever is less)
- Spectators may attend sessions (up to 50 people) as long as physical distancing is maintained. There is to be only one spectator per family and spectators will be limited to designated areas in the stadium.
- All user groups are expected to arrive ready with as much equipment on as possible before entering the stadium. Dressing rooms will be provided to put on skates and other necessary equipment. Dressing room doors will remain open in order to eliminate the use of extra high touch surfaces.
- All user groups, participants, players, coaches, and spectators will only be granted access to the stadium 10 minutes prior to the ice rental, this includes the time it takes to put on skates and other necessary equipment. Children will not be allowed in the building until association staff arrive. Upon conclusion of the ice rental there will also be 10 minutes in which the building must be vacated using the dedicated exit with the association staff being the last person out. For everyone's safety, there will be no re-entry to the stadium once inside.

- Cleaning log sheets will be available for public view to ensure all frequently touched surfaces in the stadium are disinfected between user group.
- Everyone who is in the stadium are expected to maintain 2 metres or 6 feet between all household bubbles, at ALL TIMES, on or off the ice. Physical distancing markers will be placed throughout the stadium, and appropriate signage will be placed to remind all user groups, participants, players, coaches, and spectators to adhere to the social distancing measures. This will include maximum users in each area such as benches, bleachers, etc.
- Food and Beverage services may only be provided if through a licenced food service provider that complies with the guidance for restaurants. (curbside pick up only).
- No food or drink is permitted inside the stadium, except for on ice user water bottles.
- All user groups must bring their own water bottle and not share with other participants
- Sports taking place in the stadium are to be brief contact during alert level 2.
- Physical congratulatory gestures, such as high fives and handshakes are not permitted
- Group huddles are not permitted.
- As long as public health guidelines are being followed (and governing bodies allow, example: Hockey NL etc.) single game/matches between sport teams are permitted. However mid to large scale competitions are NOT permitted in alert level 2.
- Teams may have to make adjustments to accommodate on ice play as the number of players permitted in the bench area and overflow space provided are limited to conform to physical distance measures.
- Competitions games and tournaments may only be held if the teams participating are within the same health authority
- Game/tournament organizers will be responsible to provide a copy of this agreement to any visiting team(s) and ensure it is signed and submitted along with the coinciding contact tracing information. This information must be submitted to stadium staff before ice time.
- There will be no social gatherings or loitering permitted after ice rentals. Physical distancing must be maintained in the parking lot and when returning to vehicles.
- There are other specific guidelines that must be complied when other rental agreements are in place (i.e. Birthday parties) in which a corresponding agreement form will be provided.
- One public washroom will be available and will be disinfected between each user group. Supplies will be replenished regularly.
- No spitting will be tolerated inside the stadium as this is a very high-risk safety concern.
- Anyone not following the Covid-19 regulations set by the Town of Lewisporte will be asked to leave. Safety is our number one concern.
- The Town of Lewisporte reserves the right to make changes to this user agreement form as varying circumstances may warrant.
