**SUPPLY OF GRANULAR BASE MATERIAL AND EQUIPMENT RENTAL**

**TENDER DETAILS**

The Town of Lewisporte is accepting price quotes for the supply of:

- 1). Granular Base Materials – Schedule A**
- 2.) Equipment Rental – Schedule B**

Bidder is required to complete various ongoing maintenance and town executed construction projects. The term of the contract will be for a period of one (1) year with an option for renewal for one (1) extra year. Please use the attached forms to submit your tender.

Materials shall conform to the gradation requirements as given in Table I, below. The gradation shall not show marked fluctuations from opposite extremes of the limiting sizes and the plotted curve shall flow in a manner free from acute changes in direction.

Schedule A and Schedule B are approximate only and the quantity of material or rentals can be raised or lowered at the discretion of the Town. No claim or re-negotiation of the unit bid price will be entertained or honored on the basis of increase or decrease from the estimated quantities.

The commencement date for contract is April 1, 2021 and expires on March 31, 2022

1. Selected materials will be measured in tonnes of materials delivered to the Range Road Storage Site or alternate location (s) within the Town of Lewisporte.
2. Viewing of storage site - Contact Superintendent of Works 8:30 a.m. - 4:30 p.m. Monday - Friday @ 535-2737

3. Bidder is responsible to provide pricing for all items, failure will result in disqualification.
4. The successful bidder must have the capability to weigh product and provide weigh slips at the time of delivery. In order to satisfy this requirement, the supplier must ensure that weigh devices have been approved, inspected, and certified by Measurement Canada staff or by an Authorized Service Provider. Supplier must maintain weigh device and provide the Town with a current inspection slip upon request. Failure to accurately provide weigh slips will result in the termination of contract. The Town recognizes that not all bidders may have weigh devices but will award contract with the understanding that weigh devices will be operational at contract commencement date. If such weigh device is not operational at commencement date successful bidder will be disqualified. The Town of Lewisporte reserves the right to have an employee at the scales to confirm tonnage at time of weighing.
5. Since the demand for product will vary throughout the year, the supplier must deliver equipment and/or material in quantities acceptable to the Town of Lewisporte within 48 hours of such a request. In certain emergency situations, as deemed by Town management, an immediate response time is required, and the Town reserves the right to purchase/rent outside this agreement.
6. By signing Schedule C – Bid Submission Total, bidders agree that the bid price/prices are binding and not subject to any increases during the agreed one (1) year term. Any extension of agreement into year two (2) must be agreeable to the Town and the item bidder. The price bid will be the price that the Town will compensate Contractors for each individual aggregate/equipment requirement. Should a supplier be unable to supply the product or service, for the submitted price quote, the Town will have the right to cancel its request and re-evaluate its requirement for that particular product or service.
7. Prices tendered for aggregates shall be FOB Town of Lewisporte Storage Site or alternate location (s) within the Town of Lewisporte. Prices for Equipment shall indicate the rate per hour, including all related costs, i.e.: fuel/insurance/maintenance/etc. Daily rates shall be for 8 hours, Weekly rates shall be for 5 days, Monthly rates shall be for 30 days
8. The Town utilizes the successful bidder to pick up and deliver winter salt from The Highways Depot located on Junction Highway to the Towns salt shed, it is a requirement of the Highways department that all contractors providing this service be COR Certified. Bidders for both Equipment and/or Aggregate tenders must supply, with Tender submission, a Newfoundland and Labrador Construction Safety Association (NLCSA) Letter of Good Standing under the

Certificate of Recognition ( C O R ) program, or a letter from NLCSA advising that the certification process is in-progress.

9. Bidder must provide proof of general liability insurance.
10. No work to be performed without Town issued Purchase Order
