Mayor's Report

Mayor Freake brought awareness for Autism; April is Autism Awareness Month. She thanked those individuals and groups who wore their sunglasses yesterday to show their support, "Be Cool for Autism" and encouraged residents to celebrate during the month of April.

Mayor Freake also brought awareness for national organ and tissue donation by announcing April 7 as Green Shirt Day, brought about by parents of Humboldt Broncos defencemen Logan Boulet. It is also national organ and tissue donation week April 24-30.

Heritage Society/Committee – appointment of Councillor Hannem to this committee.

Economic Diversification - meetings with Consultant George Osmond as well as partners in the Town to discuss both the economic diversification fund as well as the future of the wharf and infrastructure. Councillor Pond will elaborate in his report through the economic development committee.

Concerned Citizens Committee – we have met on a number of occasions and are engaged in ongoing communication regarding the recruitment and retention of physicians in this community as well as additional HR matters requiring support, which resulted in correspondence with Central Health.

Other Recreation

The Town of Lewisporte has received a grant for \$2000 from the Government of Newfoundland and MMSB to host a Come Home Year Community Cleanup. This funding initiative will support the cleanup of litter or improperly disposed bulk items in areas such as roadsides, trails, beaches, parks, and outdoor recreational spaces.

The Town of Lewisporte has received \$7,500 in funding from the Community Healthy Living Fund for upgrades to the multi-use/ski trail system.

The Town of Lewisporte has received \$4,550 in funding from the Community Healthy Living Fund to host a community-based wellness program.

Update by Councillor Pond

5.2 Glamping Pods

As per the Municipalities Act, 1999, the Town of Lewisporte Issued a public RFP "Ground lease of Property at 13 Range Road" the RFP closed on March 4th, 2022, with one bid submission. The proposal consisted of installation, maintenance, and operation of privately owned "Glamping Pods". A careful review of the RFP was conducted to ensure it met the RFP requirements and was complimentary to the Towns vision.

As the proposal met all requirements, I hereby motion to accept the submission and instruct the Town Clerk to enter into a lease agreement with the successful applicant.

Meetings with various stakeholders have been held over the last few weeks to evaluate options regarding the port infrastructure. The committee is hoping to bring a strategy forward in the next few months.

The first meeting of the economic diversification was held, along with officials from various government departments to discuss implementation of the committee's strategy and utilization of the funds. Officials will bring back the discussions and develop a strategy and get back to members as to how to move forward.

Mayor Freake commented on the amount of time and effort that will be put into the economic diversification aspect by committee members and Council in preparation for bringing forward its first proposal.

6.0 Lands Committee

6.1 Update by Councillor White

7.1 Update by Councillor Mullett

Councillor Mullett said that he attended his first meeting as a part of public works but had nothing to bring forward at this time.

8. Protective Services

8.1 Update by Councillor Tucker

The protective services committee has been trying to confirm a meeting with the RCMP, hoping that the meeting will be scheduled within a few weeks with representatives from the Gander District and Lewisporte Detachment.

Members are hoping to meet with individuals from the Town of Campbellton regarding fire protection services within the next couple of weeks.

8.2 Lewisporte Regional Fire Department Report - Fire Chief Lee Whiteway

Completed 160 hours of practice and meetings since the last report.

Responded to one structure fire with minimal damage to the residence and the residents were displaced for some time because of the damage caused. Honorable mention to Deputy Chief Chris Purchase and Firefighter Brian Hooper for acting quickly and putting out the fire and encouraging the residents to evacuate. This all happened prior to the Fire Department being notified.

Responded to one motor vehicle collision on the highway involving two vehicles with no personal injuries.

Practices since the last report involved:

- 1. Ice water rescue review and maintenance of ice rescue equipment and we are planning an actual scenario of persons in the water tomorrow night either at the pond or in the harbour. So, if you see us in the community, please feel free to watch from a safe distance.
- 2. A pumper practice was conducted and well attended and all aspects of the policies for pumping operations were reviewed and all firefighters we required to go over the procedures with hands on practice and review.

Smoke house committee is looking at upgrades to the smokehouse going forward.

Firefighter Cody Pardy attended a 3-day vehicle extrication course in Springdale this past weekend. Taking in all aspects of emergency scene management and various vehicle rescue with the newest techniques in the field.

Chief and Asst. Chief are working on, and almost complete, in getting prices of what's needed to upgrade the SCBA compressor cascade system to optimize the potential filling capacity for the new SCBA purchased.

The fire department also wanted to remind residents to please not trust the ice conditions now with the mild temperatures and snow covering the ice.

Councillor Tucker said there would be a meeting between protective services members and executive of the fire department in the next couple of weeks.

If you had a business in Lewisporte and did not notify the Town Office that you are no longer in operation, please let us know. Businesses will continue to be taxed until we are notified.

Any taxes prior to 2022 are overdue, please make every effort to pay off those balances. In February, finance announced that the Town would be issuing a 60-day water shut off notice to residents or businesses for overdue accounts, unless satisfactory arrangements were made with the Town Clerk. Residents and business owners can expect those notices in the coming days.
